

Fund Outline

The Fund aims to maximise risk-adjusted total returns to investors by identifying and investing in a number of investment funds (underlying funds) with a focus on those assessed to have superior return potential. The Fund will be managed principally by adjusting the mix of underlying funds. Investing in underlying funds means the Fund can be exposed to a broad range of investments and asset classes. The goal is to manage the mix of underlying funds so as to obtain the combination of investment strategies that Bateau Asset Management believes will achieve the Fund's objectives. Initially the Fund will be up to 100% invested in the Ddraig Equity Fund, an underlying unlisted fund domiciled in the Cayman Islands, committed to delivering compelling risk adjusted investment returns with a focus on opportunities across global equities.

The Fund targets a return of 8-11% p.a. after fees and expenses over a period of 5 years.

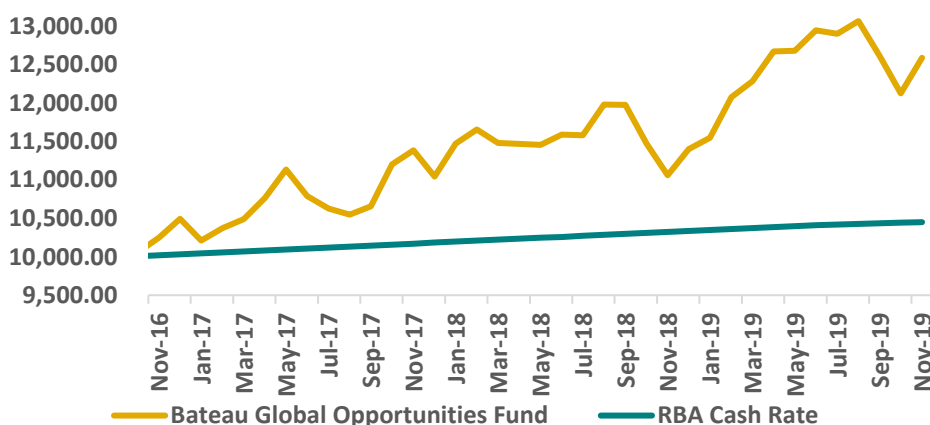

Global Markets Update:

- US markets. US markets were stronger in the month, with the Dow Jones up +3.72% and S&P500 up +3.40%.
- Long-dated US treasury yields were mixed, with the 2-Yr yield lower at 1.61% and 10-Yr yield slightly higher at 1.78%.
- European markets. European markets were higher with the Stoxx Europe 600 Index up +2.69%, UK FTSE up +1.35% and German DAX up +2.87%.
- Asian markets. Asian markets were mixed over the month, with the Nikkei up +1.60%, KOSPI up +0.22% and the Shanghai Composite down -1.95%.
- Commodities. Over the month, WTI oil price gained +1.70% to US\$55.17/bbl, iron ore prices declined -1.24% to US\$83.67 per tonne and spot gold declined -3.24% to US\$1,464 per ounce.
- ASX performance. The ASX200 gained +2.74%.

In political news:

- China's foreign ministry warned of retaliation for U.S. President Donald Trump's signing of legislation that expresses support for protesters in Hong Kong raising concerns about the prospect for an interim trade deal between the world's two biggest economies.
- U.K.'s Brexit Party decided not to contest Conservative seats in the upcoming U.K. election, bolstering Prime Minister Boris Johnson's efforts to leave the European Union.
- Spain's ruling party struck a coalition with anti-austerity political party Podemos.
- All conservative candidates pledged to back Prime Minister Boris Johnson's deal to exit the EU.

In economic news:

- Australian RBA decision. The RBA left the cash rate unchanged at 0.75%.
- Global growth outlook. WTO forecast the trade in global goods to remain below trend through the quarter amid heightened tensions and rising tariffs.
- OECD trimmed its global economic growth forecast for 2020 to 2.9% from an estimate of 3% in September and raised the growth forecast for the euro area to 1.1%.
- U.S. GDP expanded at an annualized 2.1% in third quarter, better than the initially reported 1.9% and the prior period's 2%.
- U.S. jobless claims climbed to the highest level since June, exceeding economists' forecasts.
- China's economy decelerated with fixed-asset investment slowing to 5.2% in the first 10 months of 2019 (lowest reading in comparable data back to 1998) vs a forecast of 5.4%.
- Germany's industrial output worsened, and the nation narrowly dodged a technical recession with economic growth of 0.1% in the third quarter.
